

THE FINE PRINT:

1. ELIGIBILITY:

The "Choose Your Own Adventure Raffle" ("Raffle") is open to legal residents of Texas who are eighteen (18) years of age or older at the time of entry. Raffle ticket purchaser ("Purchaser") will be required to submit address at time of entry, and winner will be required to show proof of Texas residency via Texas-issued Driver's License or government-issued identification. Purchasers must be physically located in Texas at the time of ticket purchase. Employees, contractors, directors, and officers of The Arc of the Capital Area ("Agency"), and members of their immediate family (spouse, parent, grandparent, child or sibling) residing in the same household, are not eligible to enter or win. The Raffle is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes Purchaser's full and unconditional agreement to these Official Rules & Regulations.

2. CONTEST PERIOD:

Raffle begins at 12:00am Central Standard Time ("CST") on August 10, 2022 and ends at 6:00pm CST on November 6, 2022 ("Contest Period"). Winner will be selected and announced on November 6, 2022 at 6:00pm CST via announcement at The Arc's Art Celebration as well as on the Agency's social media and the Agency's website. The Agency's computer is the official time keeping device for this Contest Period.

3. HOW TO ENTER:

During the Contest Period, look for Agency's announcement via the Agency's social media, email newsletters, and direct mail inviting constituents to enter for a chance to win a prize. Visit www.arcaustin.org/raffle and follow the online instructions to purchase Raffle ticket(s).

If entering with a mobile phone or other web-enabled device and using your wireless carrier's network, standard data charges from your wireless carrier may apply. Check with your wireless service provider for details on these and any other applicable charges. Purchasers are solely responsible for any such wireless charges.

All Raffle ticket purchases must be received and recorded during the Contest Period. No other forms of Entry are valid. Participants will receive the ticket with name and address of Agency, ticket price, prize description, and date and time of raffle award notification printed on the ticket.

4. WINNER NOTIFICATION:

Agency will select winner and ten (10) alternate potential winners utilizing RandomPicker.com software, an independent service for random drawings. An online certificate will be available proving unbiased draw details. The prize will be awarded, and winner will be notified via direct message and will be required to respond to the notification within forty-eight (48) hours indicating whether he/she can accept the prize. If a potential winner does not respond to the notification within the forty-eight (48) hour time period, prize will be forfeited and an alternate potential winner will be selected in numerical order of the selection of the ten (10) alternate potentials. The list of ten (10) alternate potential winners will be notified as the next potential winner in the order of their selection. Any alternate potential winner selected will also be required to respond to the notification within the time frame stated above.

Potential winner will be required to complete, sign and return to Agency a (1) Publicity Release; and (2) Release and Waiver of Liability and Assumption of Risk within seventy-two (72) hours of prize acceptance. These documents will be available for Purchaser's review on the Raffle Ticket Purchase site prior to ticket purchase, as well as on the Agency's website: www.arcaustin.org. Subject to compliance with the terms of these Official Rules & Regulations, including verification that the winner is eighteen (18) years of age or older, the potential winner will be declared an official winner of the Raffle. If Agency cannot verify that the potential winner is eighteen (18) years of age or older prior to winner notification, then the potential winner will be disqualified and an alternate potential winner will be selected in accordance with the procedure set out in this Section of the Raffle Rules.

Winner's guest will be required to complete, sign and return to Agency a Release and Waiver of Liability and Assumption of Risk within seventy-two (72) hours of winner's prize acceptance. These documents will be available for guests' review on the Agency's

website prior to ticket purchase: www.arcaustin.org. If guest is under the age of eighteen (18), Release must be signed by parent or guardian on his/her behalf.

In the event of noncompliance within any stated time period, the potential winner will be disqualified and the first alternate potential winner on the list of ten (10) alternate potential winners will be selected as the potential winner. Any alternate potential winner selected will also be required to adhere to the time periods described herein. If the alternate potential winner is disqualified, the next alternate potential winner on the list will be selected. This procedure will continue until the selected alternate potential winner is not disqualified and is declared the official winner of the Raffle. Release Parties (as defined below) are not responsible for suspended or discontinued Internet, wireless, or land-line phone service or a change in Purchaser's email, phone number or mailing address which may result in a potential winner not receiving initial prize notification or his/her prize information.

5. PRIZE DETAILS:

Potential Winner and guest will receive their choice of one of the four advertised destinations, and trip must occur within 2 years of granting of prize. See Raffle description for details of included amenities, such as ground transportation, meals, gratuities. Any affiliated expenses not specified herein are solely the winner's responsibility. If the potential winner cannot accept prize as specified, the potential winner will be disqualified and the alternate potential winner will be selected in accordance with the procedure set out in Section 4 of the Rules. Value will be determined at the time the destination is determined. There is no cash option, and no substitutions on the prize will be made.

If the prize cannot be awarded for any reason, including Acts of God, acts of terrorism, civil disturbances, COVID-19 or any other natural disaster outside Agency's control, then Agency will set another award date no later than 30 days from November 6, 2022.

Prize is non-transferable and no cash equivalent or substitution of prize is offered. If prize, or any portion thereof, cannot be awarded for any reason within 30 days from November 6, 2022, refunds of the amount paid by each person who purchased a ticket for the Raffle will be offered to Purchasers.

The Arc will pay the required federal tax withholding on behalf of the prize winner if federal tax is applicable.

6. DISPUTE RESOLUTION:

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules & Restrictions, or the rights and obligations of the Purchaser and Agency in connection with the Raffle, or any claim or dispute that has arisen or may arise between you and Agency shall be governed by, and construed in accordance with, the laws of the State of Texas without giving effect to any choice of law or conflict of law rules.

7. PRIVACY POLICY:

If you are determined to be the prize winner, your first name, last initial, city and state will be included in a publicly- available winner's list.
